2016 SHIFTING BATTLE LINES

From the historic razor-thin 3-2 CPUC vote to save Net Energy Metering in January to the proposed Time-of-Use rate structures that threaten to undermine the economics of solar, 2016 ushered in shifting battle lines for the California solar energy market that will define 2017 and beyond.

This shift in approach to slowing down the solar market from NEM to rate structures makes the work of CALSEIA ever more important – not only our work to represent the industry in the most critical decision-making forums in the state, but our ability to quickly turn around and inform you about these changes.

On behalf of the CALSEIA Board of Directors and staff, we thank you for your ongoing support.



2016 Program Highlights



FIGHTING FOR NET METERING

The CPUC decision came in January, but the debate over the final tariff language continued through June. The utilities attempted to expand the assessment of non-bypassable charges, limit NEM grandfathering, and add departing load charges for some customers. CALSEIA fought for a strong NEM decision and then pivoted to block the implementation moves by the IOUs.

TIME-OF-SANITY

TOU rate structure took center stage as the battlefield for solar shifted away from NEM. Utilities and Cal-ISO proposed to move summer peak to the evening hours with no grandfathering. CALSEIA pushed back with load analysis and by bringing real stories of impacts on customers to the halls of the CPUC.

STORAGE

We continued stepping up our work on energy storage in 2016. The SGIP solicitation in February did not go smoothly and took months to sort out. Then the CPUC considered changes to the incentive structure. We successfully got 75% of the funds dedicated to storage and made money that had been reserved for future years available sooner. We also added a storage company to the CALSEIA Board of Directors and put in motion plans to hire a storage-dedicated policy advocate to the CALSEIA team.

THERMAL

The massive leak at Aliso Canyon spurred state action to promote solar thermal technologies given their large potential to reduce natural gas use in the state. In fact, installing solar water heating on just 7% of the multi-family buildings in LA offsets the annual natural gas demand for withdrawals from Aliso Canyon for buildings in LA. At our encouragement, the state boosted CSI-Thermal rebates in SoCalGas territory, and we worked with SoCalGas to ensure the program worked for singlefamily homeowners. We also came excruciatingly close to passing a \$250 million statewide boost to the program for the next five years.

PERMITTING & SOFT COST REDUCTIONS

Soft costs account for as much as 64% of solar's total installed costs, according to the DOE. We

increased outreach efforts to help jurisdictions across the state implement AB 2188, the law to streamline permitting and make solar cheaper and easier for everyone. In addition, through our permitting hotline, we addressed at least one member permitting concern per week. CALSEIA also pressed for official national and California code clarifications, saving thousands of dollars for every installation that now avoids unnecessary center-fed panel upgrades.

SOLAR FOR ALL

We continued our efforts to expand access to solar for all Californians. We outlined our vision for how to implement AB 693, a new solar rebate program for tenants of low-income multifamily housing projects, and continued to advocate for the diversification of the market under NEM 2.0.

MUNI NEM

All of our efforts to protect NEM at the CPUC unfortunately have no impact on the state's 40+ publicly owned utilities. Imperial Irrigation District (IID), for example, pulled the plug on NEM in February stranding 1200+ solar customers, many with solar on their roofs awaiting interconnection. CALSEIA fought tooth and nail and won a concession, negotiated by the state legislature, forcing IID to give full NEM status to the vast majority of these solar customers.

GRID MODERNIZATION

Issues related to grid modernization consumed a lot of brainpower. Utilities are improving their analysis of the hosting capacity of the grid, which will lead to a better interconnection process. An overhaul of the method for measuring the grid benefits from solar and storage is also underway. This will lead to development opportunities and will form the backbone of NEM-3.

NEM-A BILLING


NEM-Aggregation customers have been frustrated by bills that are late, incorrect, and impossible to understand. CALSEIA has pushed hard to get utilities to increase staff resources and improve the billing format so that a horrible customer experience doesn't poison the market for solar.

INTERCONNECTION

CALSEIA pressed utilities to stop requiring unnecessary grid upgrades when interconnecting large solar systems and won approval for access to better data on local grid conditions that helps estimate interconnection costs.

CSI-THERMAL DOMESTIC WATER HEATING

Thanks to CALSEIA's efforts to set the CSI Thermal program's rebates at levels that work for the chronically low natural gas prices, installations have increased with larger monthly natural gas reductions since rebates were fixed in February of 2015.


CHAPTER UPDATES

MEMBER EDUCATION

In addition to CALSEIA's work to advance pro-solar policy, CALSEIA also works to make policy accessible and understandable to our members. To keep members up-to-date with what's going on with California solar policy and events, the organization sent out 51 weekly updates and an additional 135 informational emails. CALSEIA's members received action alerts on NEM fights throughout the state, opportunities to meet with key elected officials, updates on the NEM policy changes every step of the way, and numerous special promos and invitations to over a dozen special events.



In 2016, CALSEIA created 13 fact sheets on everything from how to calculate non-bypassable charges to rule 21 dispute process. We also hosted nine policy education webinars and set up NEM status trackers for municipal utilities, PG&E and SCE. Members can download these resources for free from CALSEIA's website.
